CLAUSE 5: SUBSCRIPTIONS

CLAUSE 6: COMPOSITION OF THE ASSOCIATION

6.2 Management

6.2.1 The AMAGP Management Committee shall be selected annually i.a.w. its constitution.

6.2.1.1 The Management Committee shall consist of a National Chairperson, National Deputy Chairperson and up to four (4) Executive members. The committee shall be not less than five (5) members.

6.2.1.2 A Secretary and/or a Treasurer shall be appointed by Management.

6.2.1.3 Despite any change of management the Association will continue in existence under this Constitution.

6.2.1.4 **Honorary President.** The General Assembly may, at its discretion, appoint an honorary president as a Special Advisor to management. The honorary president will not have any executive powers. 6.2.1.6 The National Secretary and/or Treasurer will be responsible – 6.2.1.6.1 to handle the administration of the Association.

CLAUSE 6: COMPOSITION OF THE ASSOCIATION

6.2 Management Committee

6.2.1 The AMAGP Management Committee shall be **elected every 3 years**. Members may serve a maximum of two consecutive 3-year-periods,

6.2.1.1 The Management Committee shall consist of a National Chairperson, National Deputy Chairperson and up to four (4) Executive Members. The committee shall be not less than five (5) members.

6.2.1.2 Any Management Committee Member who becomes unavailable during the 3-year term may be substituted by a suitable member selected by the Management Committee to serve for the remainder of the period. This selection must be promulgated to the members.

6.3 **Secretary/Treasurer.** A Secretary and/or a Treasurer shall be appointed by Management. The National Secretary and/or Treasurer will be responsible to handle the administration of the Association.

6.4 Despite any change of office bearers, the Association will continue in existence under this Constitution.

6.5 **Honorary President.** The General Assembly may, at its discretion, appoint an honorary president as a Special Advisor to management. The honorary president will not have any executive powers.
