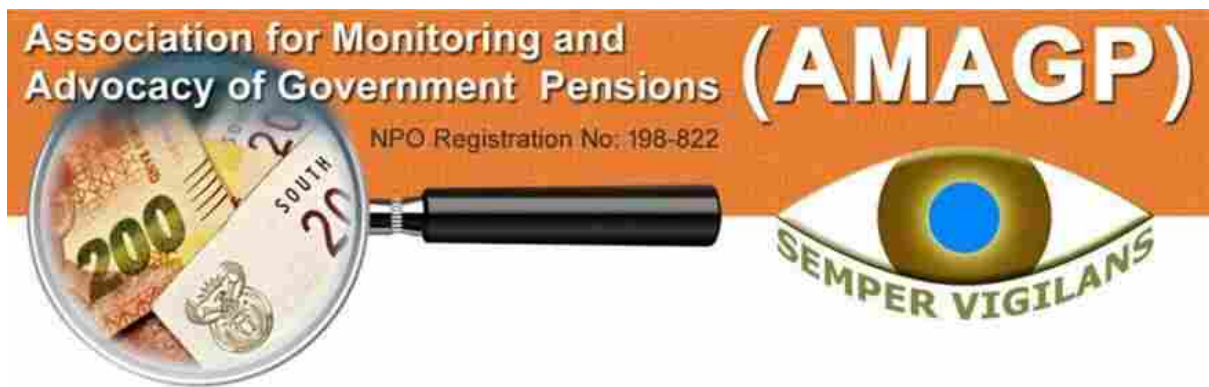

APPOLOGY BY THE SPEAKER OF PARLIAMENT

The Speaker of Parliament has apologized before the Zondo Commission for the absence of conduct and action on the side of parliament regarding state capture.

Are the Minister of Finance, the Public Investment Corporation (PIC) and the Board of Trustees (BOT) of the Government Employees Pension Fund (GEPF) going to follow her example?

On 17 October 2017 at a meeting of the Standing Committee for Finance attended by Mr AP Stemmet and a colleague on behalf of AMAGP the Chairman repeatedly asked the Deputy Chairman of the PIC and the Chairman of the Board of Trustees of the GEPF if they saw any danger for their organizations in the allegations of state capture. They continued to avoid answering his questions and, like children, he sent them home to do their homework and to return with answers.

Would it not be nice if the BOT of the GEPF in view of the findings of the Mpati Commission also apologize for the losses suffered through the PIC/GEPF. Firstly, as a result of their non-compliance with their accountability regarding the welfare of the pension fund and secondly for their lack of proper monitoring of investments? This would have saved the pension fund billions.

Maybe it is now too late for this? However, they can apologize to the pensioners for lack of action to recover losses. Or are they engaged in secret to recover billions?

Would the BOT not also make the Speaker's undertaking of devotion and action against corruption and other incongruous matters their own? The Speaker also said that Parliament supports the Zondo Commission. Does the GEPI say the same pertaining to the Mpati Commission and its recommendations?
