

## IMPORTANT STUDIES

Based on the Government Employees Pension Fund's (GEPF) annual report as well as other data, various studies regarding the status of GEPF have been concluded by experts of the Association for Monitoring and Advocacy of Government Pensions (AMAGP). The conclusions from these studies that the AMAGP have come to are detailed below. These studies play a major role in our future actions.

## ACTIONS

The AMAGP consists of a number of volunteers who are concerned about the state of our pensions. The organisation is still young and under developed (especially if it compared to the Organisation Undoing Tax Abuse (OUTA), that has been in existence for 8 years) wrt capabilities like finances and man power. The GEPF and the Public Investment Corporation (PIC) clothe themselves in secrecy and are reluctant to appear under the "magnifying glass" of the members of the fund. All this makes the actions of the AMAGP more difficult.
